

## **WEBSITE PRIVACY POLICY**

The respect of your private life is of the utmost importance for Logikit Inc, who is responsible for this website.

This Privacy Policy aims to lay out:

- the way your personal information is collected and processed. "Personal information" means any information that could identify you, such as your name, your mailing address, your email address, your location and your IP address;
- your rights regarding your personal information;
- who is responsible for the processing of the collected information;
- to whom the information is transmitted;
- if applicable, the website's policy regarding cookies.

### **1. FORMS AND METHODS OF COLLECTION**

The personal information we collect is collected through the collection methods described in the following section.

## **2. COOKIES AND LOG FILES**

**We collect information through log files and cookies. These allow us to process statistics and information about traffic on the Website, to ease navigation, and to improve your experience for your comfort.**

### **a) Cookies used by the Website**

**The cookie files used on the Website are the following:**

- **Operating system and devices used**
- **Pages visited and queries (date, time, duration and frequency of your visits)**
- **Your computer's anonymized IP address (your IP address is changed, making it impossible for others to link to you)**

**The use of such files allows us to achieve the following purposes:**

- **Remarketing**
- **Analytics**
- **Improved user experience**

### **b) Objection to the use of cookies and log files by the Website**

You may refuse the recording of these cookies in two ways:

- By configuring your browser
- By closing the cookie banner at the bottom of the page without clicking on the "Accept" button

Once you have deactivated cookies and log files, you may continue your use of the Website. However, any malfunction resulting from this deactivation shall not be considered of our making.

#### **\*Configuring your browser settings**

To block cookies, you can configure your browser's cookie settings. Most browsers are set to allow cookies by default. If you don't allow sites to save cookies, you can change your browser settings to reject all cookies, or to allow/block cookies on a case-by-case basis prior to their installation. You can also regularly delete cookies from your device via your browser.

Each browser has different settings. In general, you can disable cookies by selecting your preferences on your browser (typically accessible in your browser's "Settings" or "Privacy" tabs) for each of your devices (tablet, smartphone, computer, etc.).

Disabling all cookies may prevent you from using or accessing certain functions of our website.
